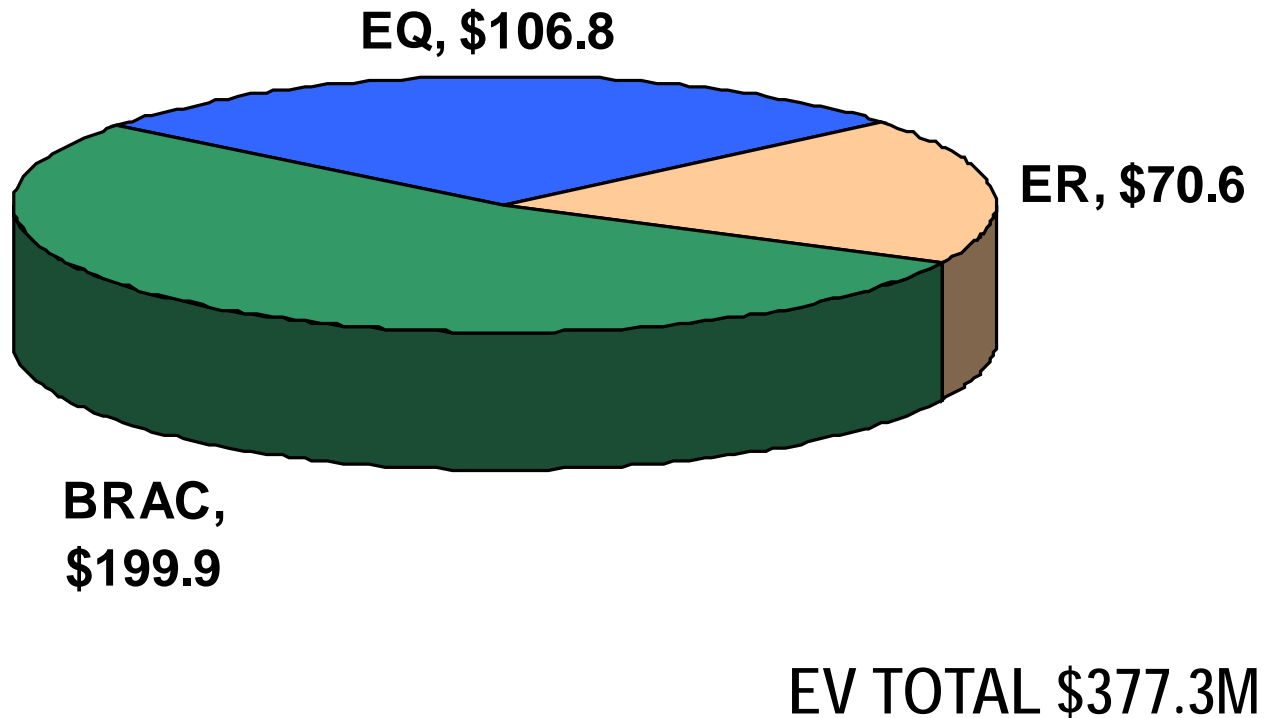

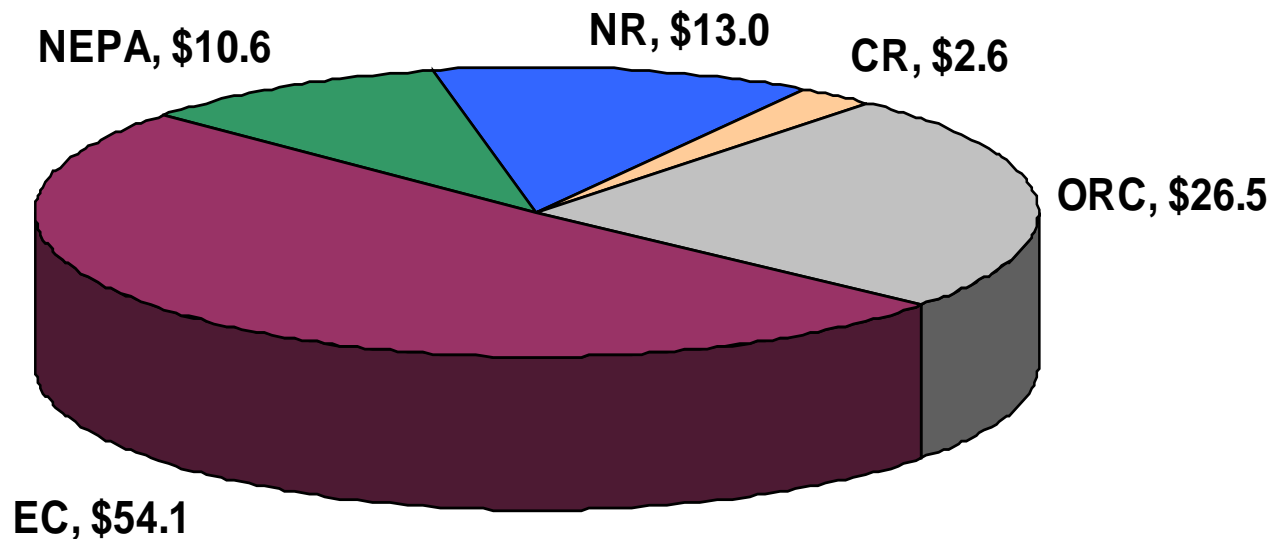


TOTAL EV Execution



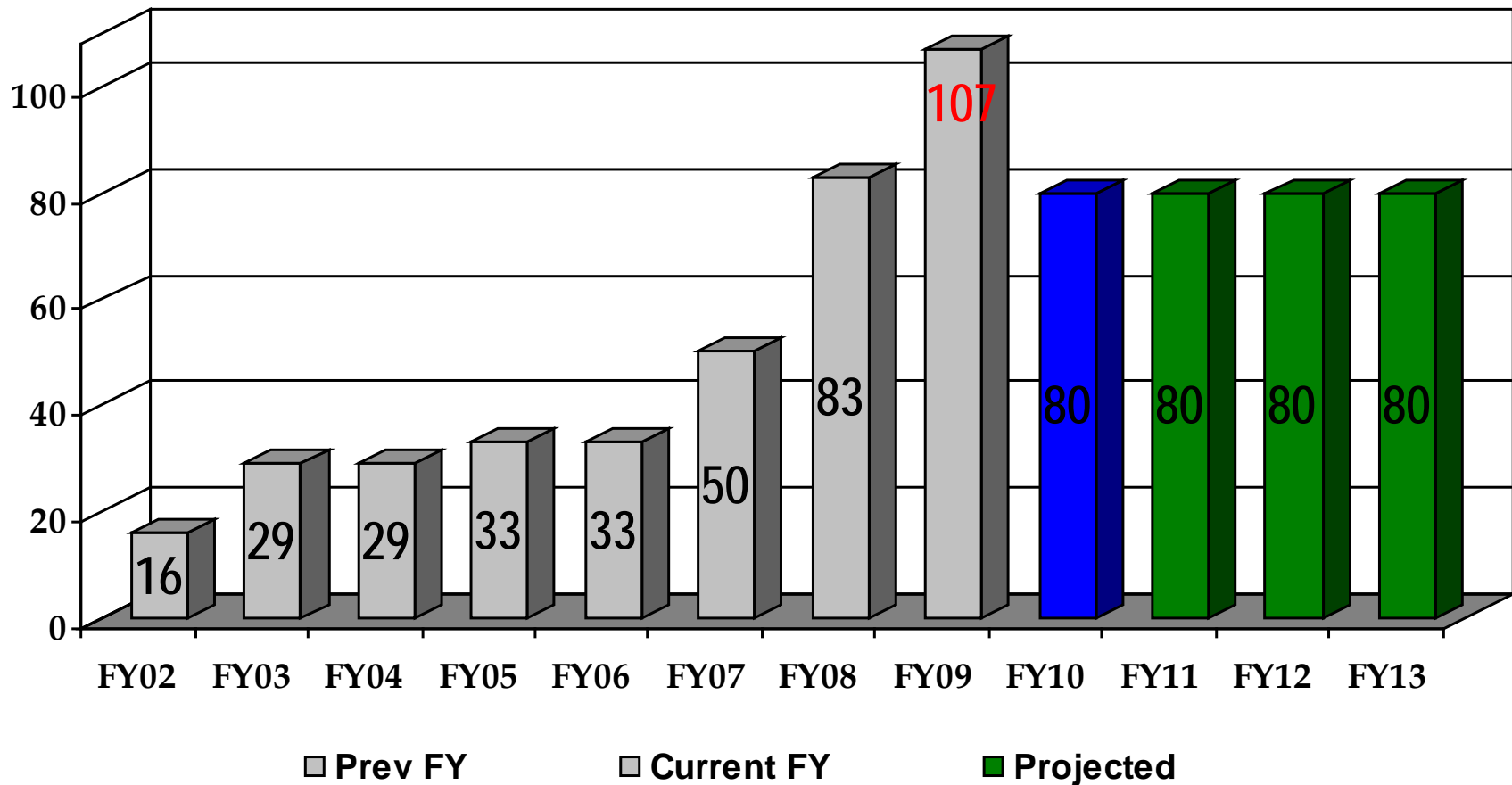


Env Quality Execution

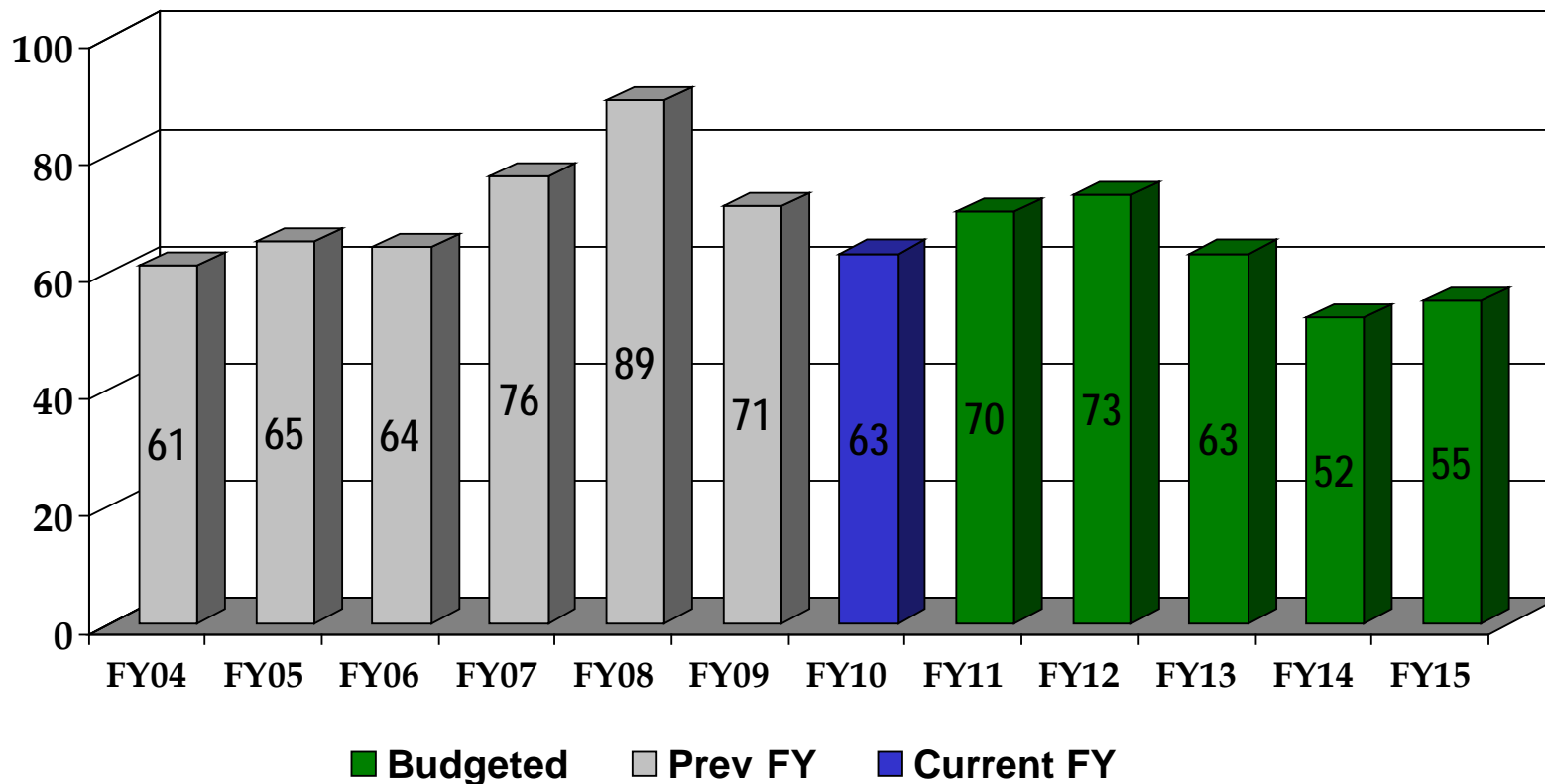
NAVFAC SW Program Budgets: *Environmental Quality*



NAVFAC SW Program Budgets: Environmental Restoration, Navy (ER,N)



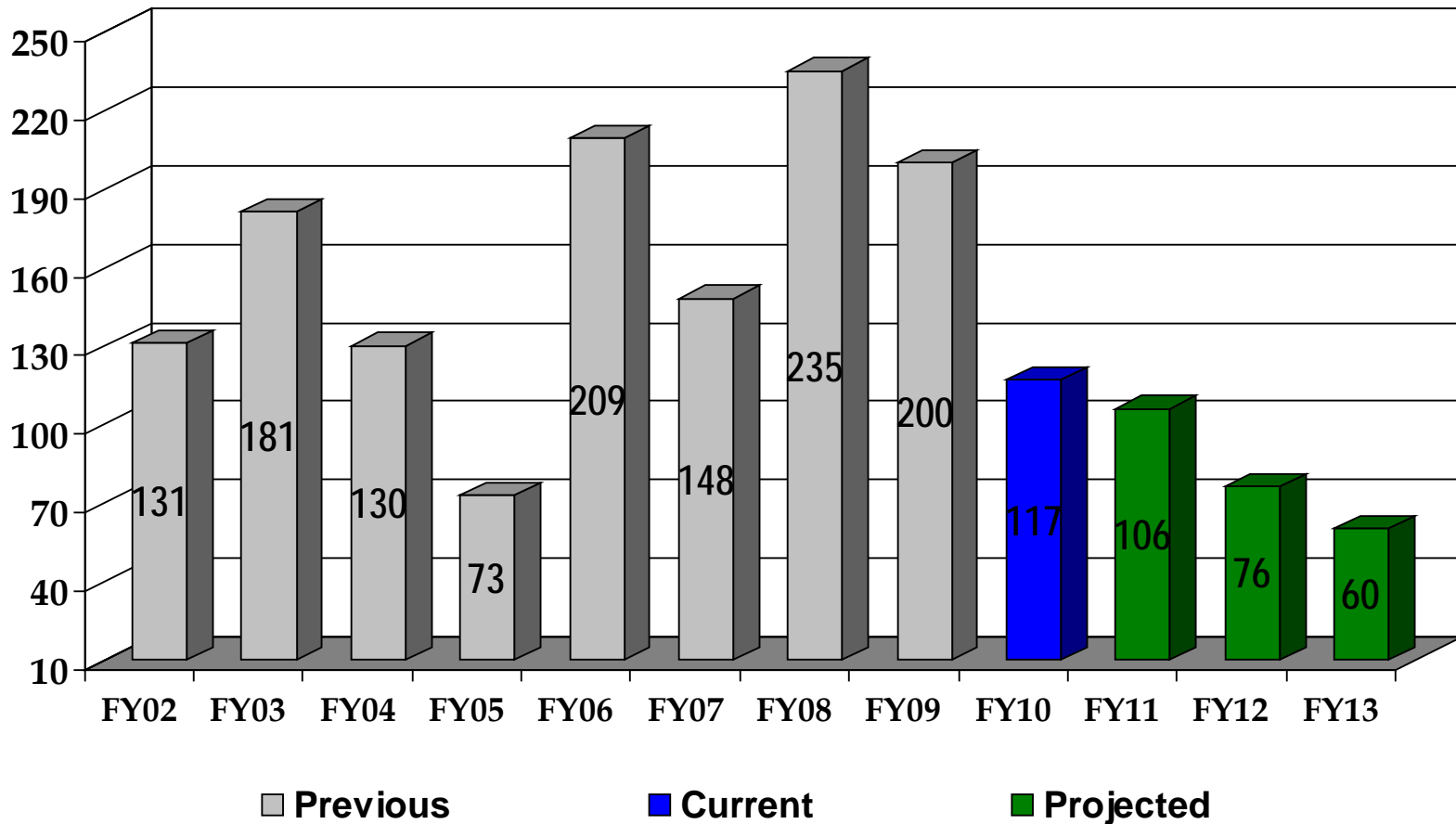

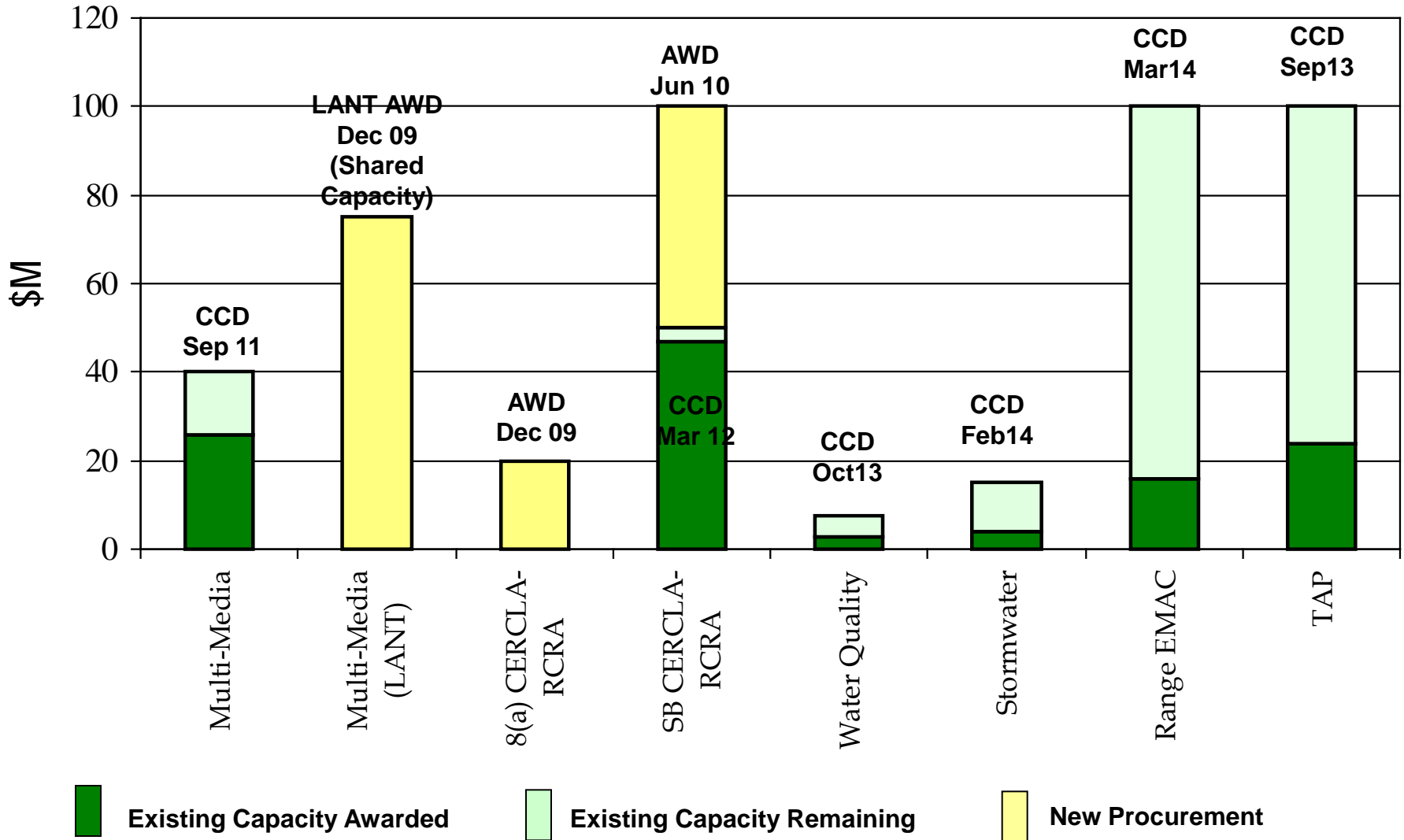
BRAC Program Management Office - West BRAC Restoration Budget



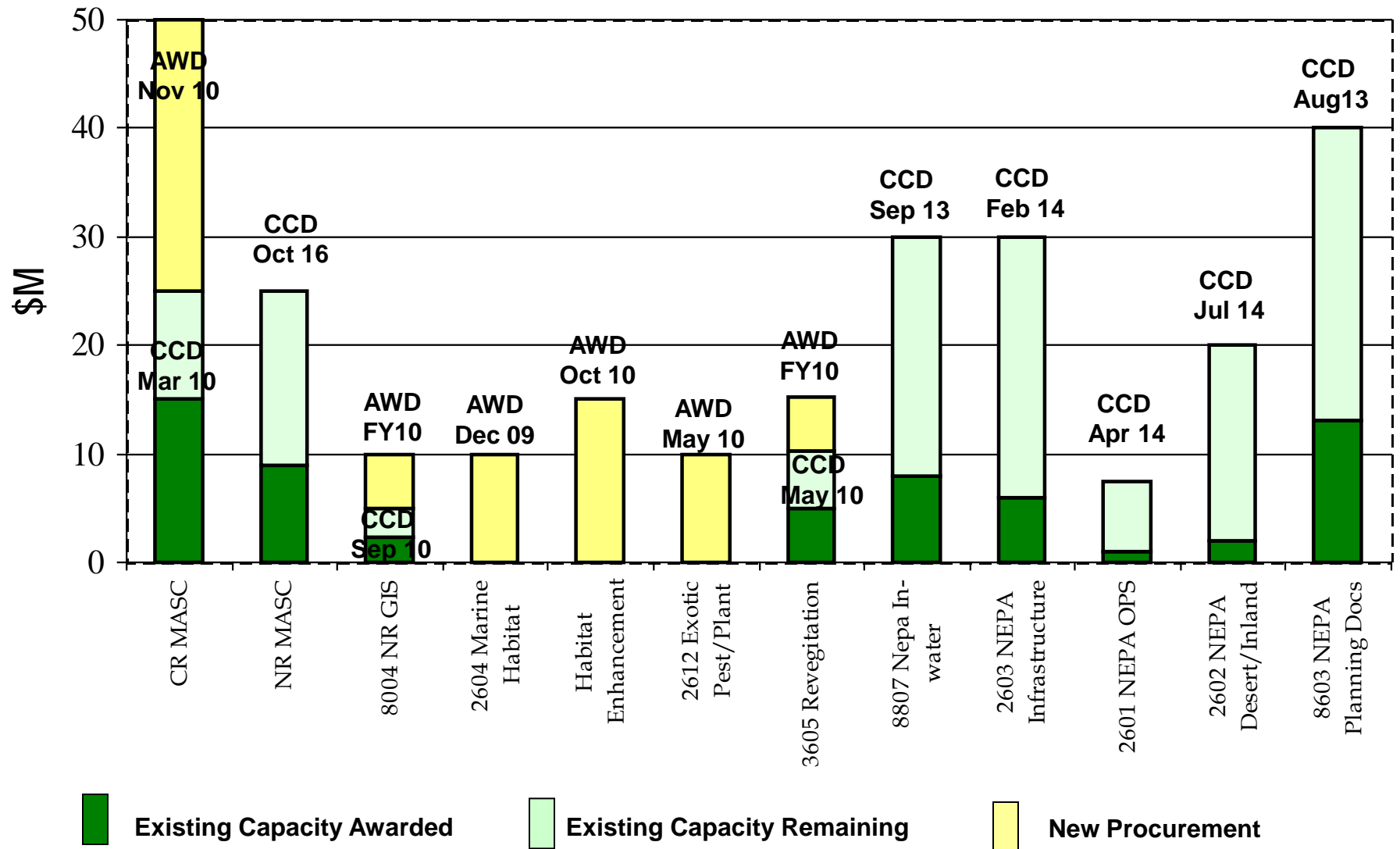

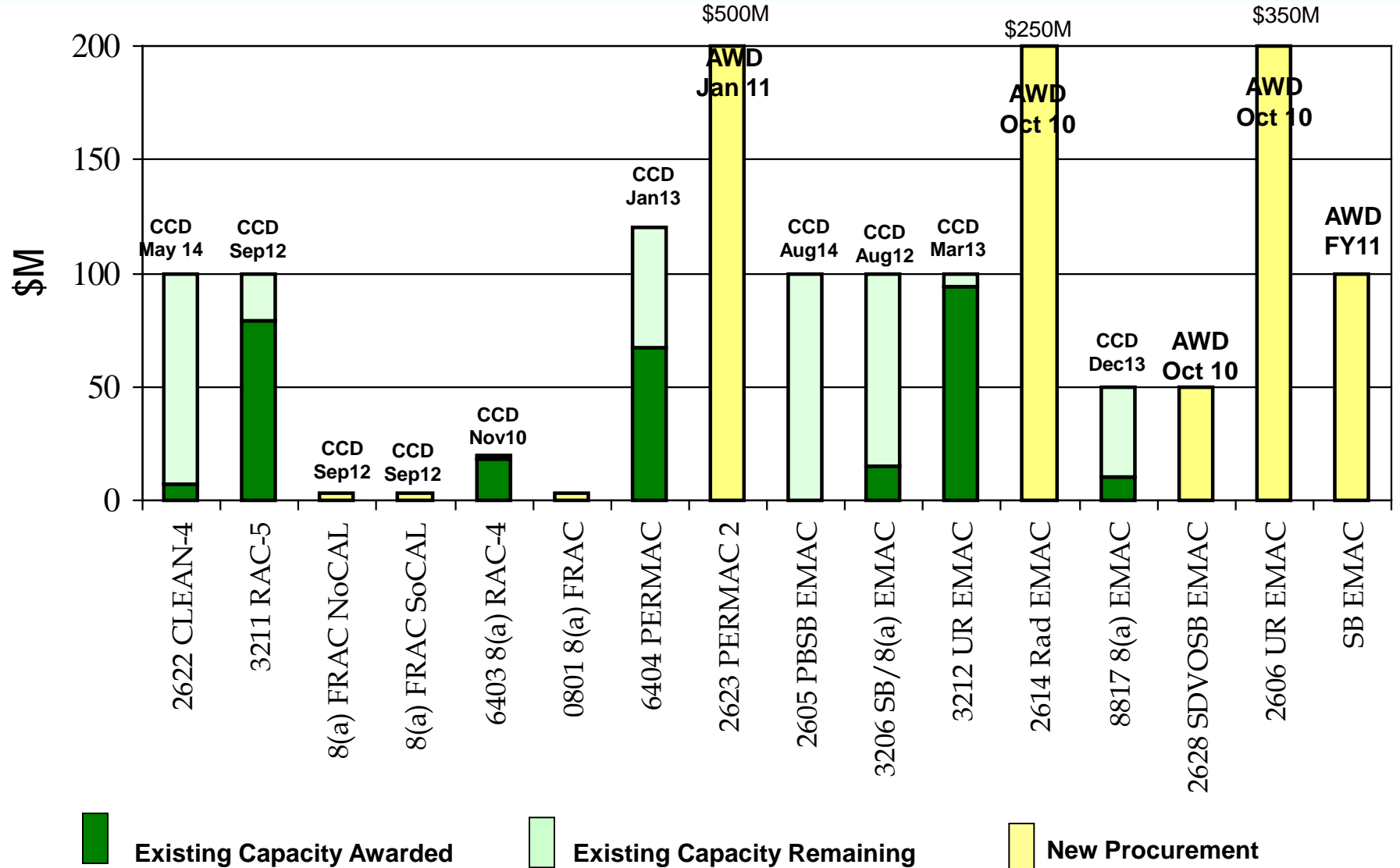
Status of EV Regional Contracts - EC
