Mission - To expeditiously and cost effectively provide all services necessary to realign, close, and dispose of DON BRAC properties through sound business management practices and transformational thinking to support the war fighter and provide savings to DON and the federal taxpayer

- Prior BRAC Actions
 - Completing real estate and environmental remediation actions for last 7% of property slated for disposal
 - Portions of 14 installations totaling 11,508 acres
 - Managing environmental program at 25 disposed installations
 - Caretaking property at 12 installations
- BRAC 2005 Actions
 - Certifying completion of 33 DON-related BRAC Recommendations
 - Working with LRAs on reuse and disposal processes at the remaining 9 installations
 - 47% remaining, totaling 8,716 acres
 - Caretaking property at 4 installations



BRAC Environmental Program



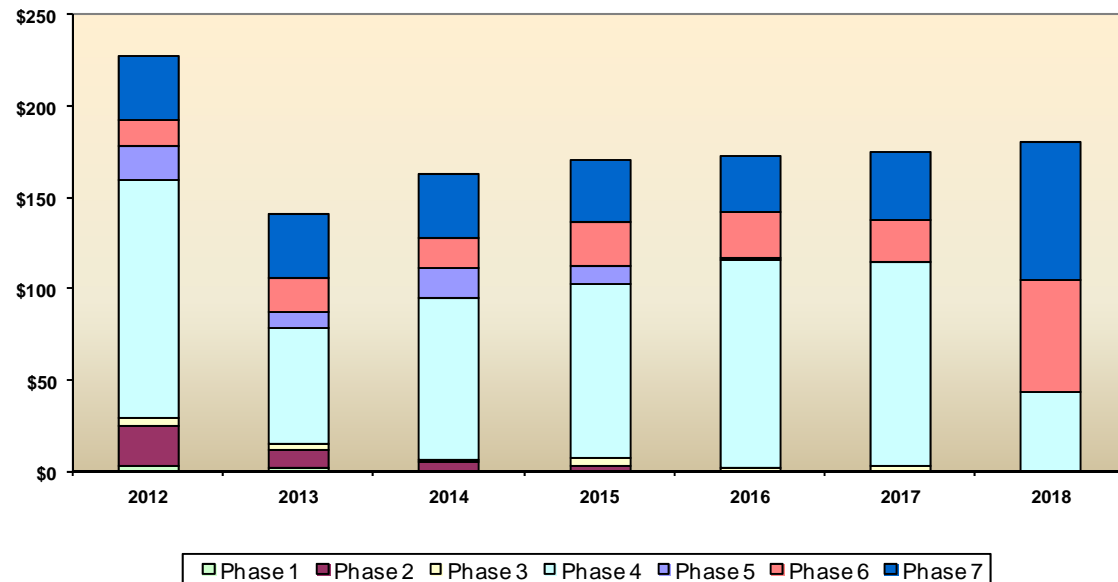
- 42 bases with legally-mandated environmental remediation efforts (includes UXO and RAD)

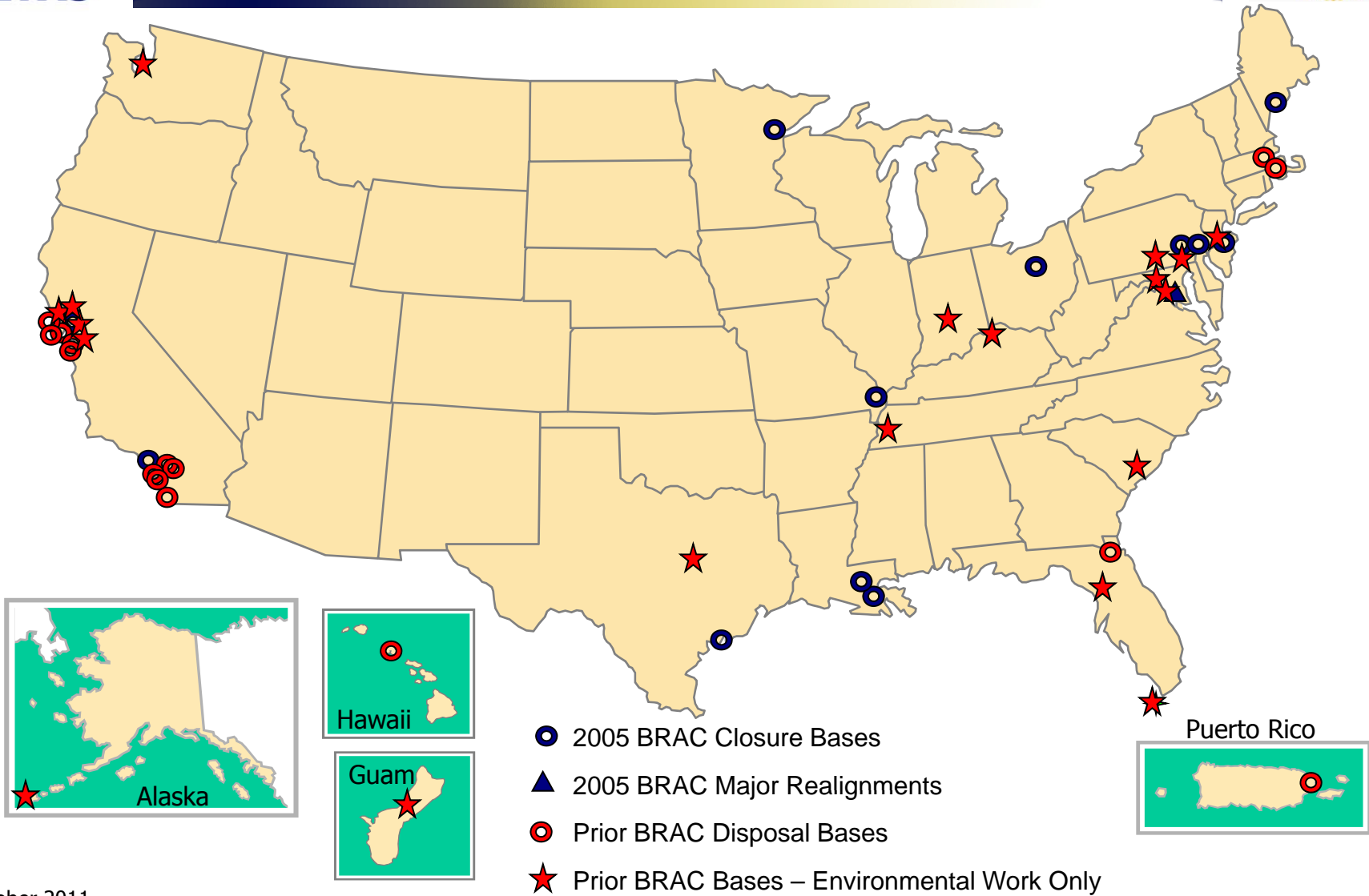

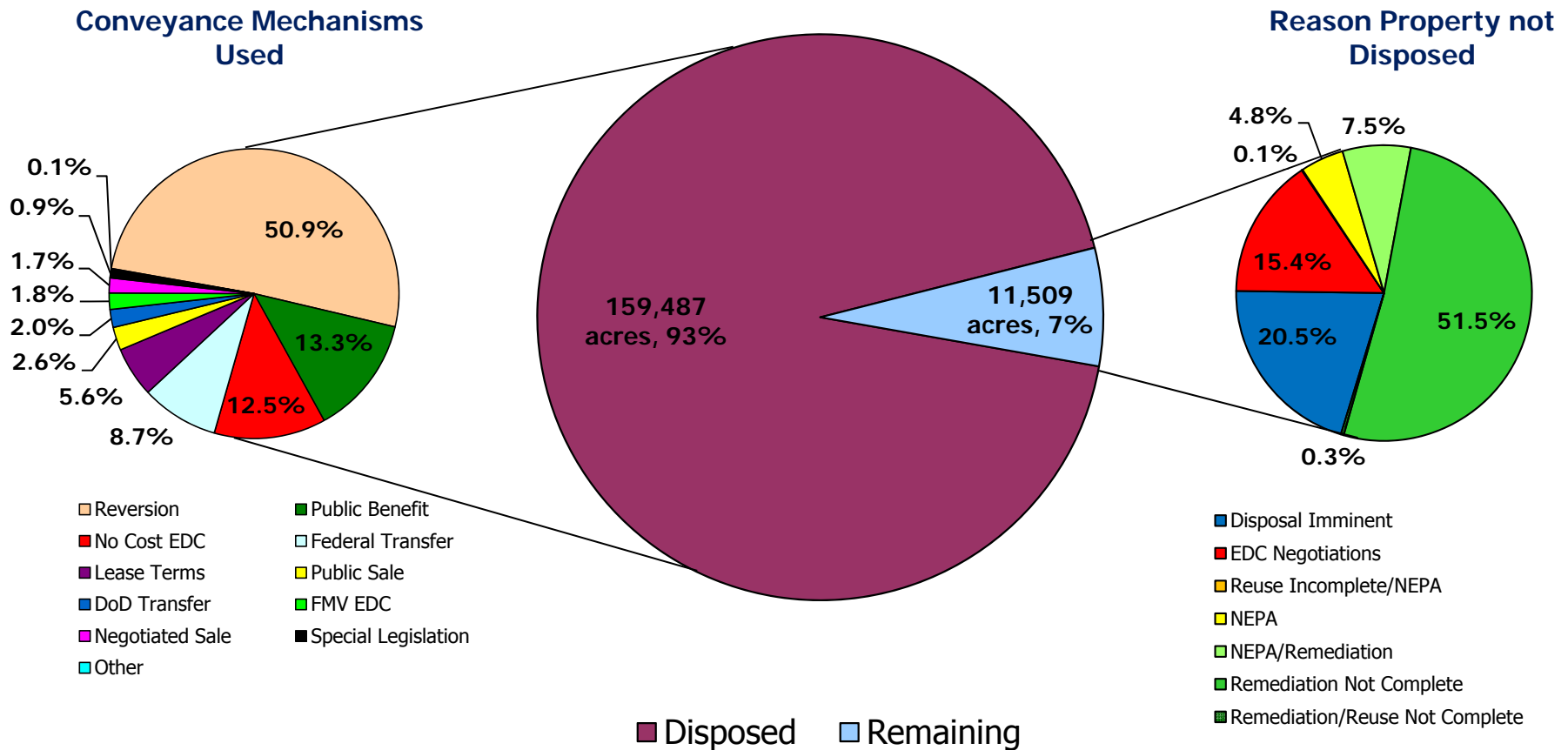

BRAC 05 Realignment



- Completed 484 realignment and closure actions by the 15 Sep 11 statutory deadline to include 102 construction projects
- Post-implementation actions in FY12
 - Complete facility construction on 12 projects at Arlington, Anacostia, Washington Navy Yard, Indian Head, Lehigh Valley, Joint Base McGuire-Dix-Lakehurst, Brunswick, and New Orleans
 - Relocate personnel under Navy Leased Locations recommendation
 - Relocate BUMED under Joint Medical Command recommendation (Army-led)
- Formal certifications of completion being completed and staffed to OSD

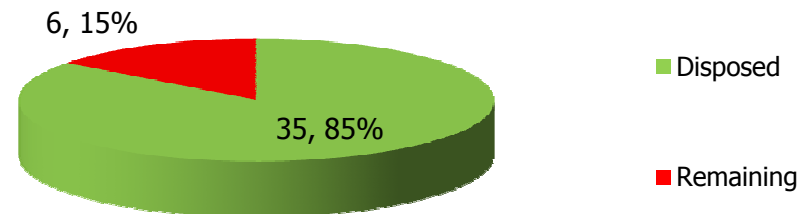

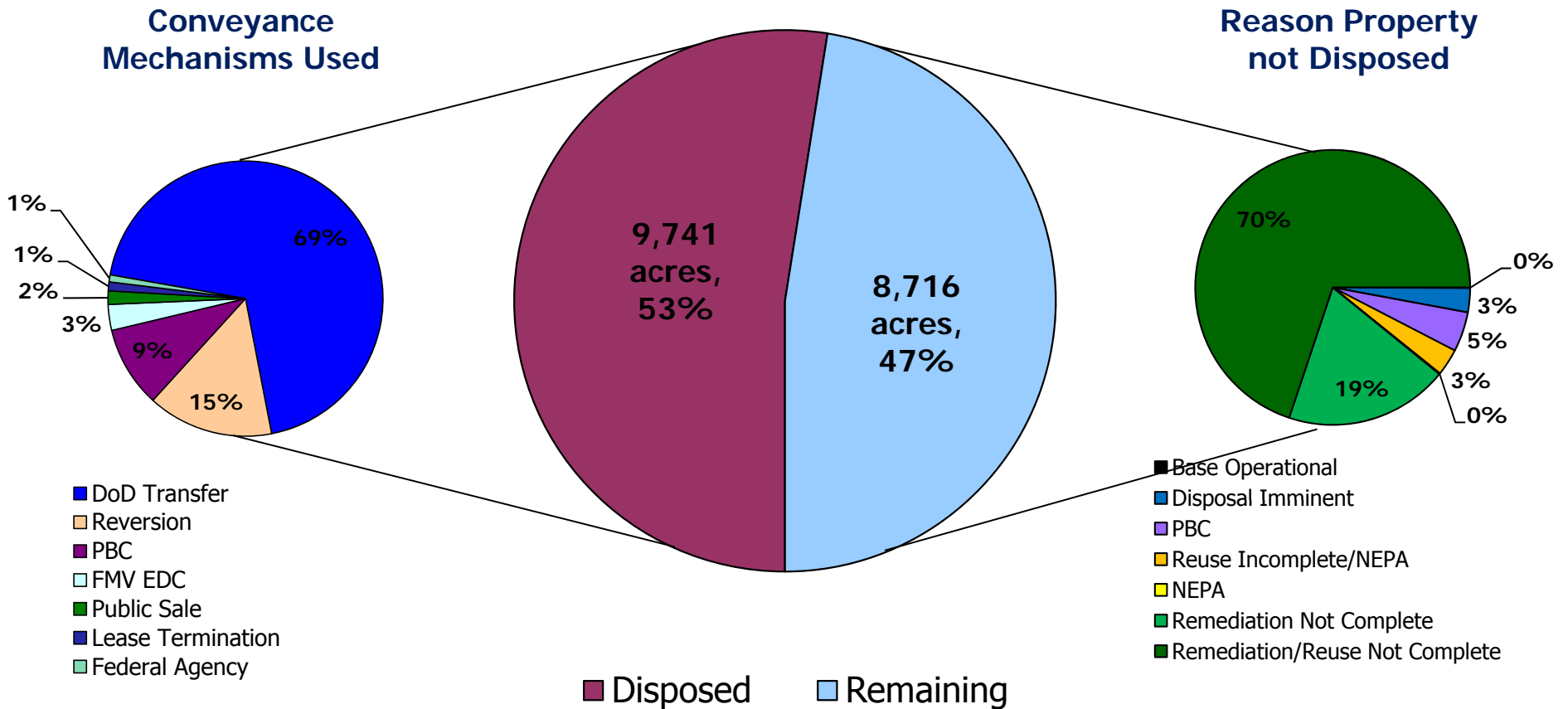


BRAC 2005 Disposal Status
